4. Set Default Activation Fees (please compete for \$0 fess and well)

 You can set default fees that the activation software will automatically add to card activation transactions.

• Fees set up as defaults can be deleted or modified by the user during the card activation if you have given the user that permission when setting up your CardSpot® user accounts. See the User Information Forms for more information on permissions.

• You have the option of creating simple structure fees, such as flat fee per card, or you can create tiered fee structures to allow for lower fees on higher dollar transactions.

• Each card type may have a different fee associated to it.



Fee Types:

Per Card Fee

- A fee charged to the customer for each card in a transaction.
- For example, a per card fee of \$1.00 results in a fee total of \$10.00 in a transaction with 10 cards.
- Per card activation fees typically range from \$1.00 to \$2.50.

Transaction Fee

- A fee charged to the customer for the whole transaction, not for each card.
- This type of fee is often used to charge for handling on a large order.

"Based On" Options:

Card Count

- The number of cards in the transaction determines the fee.
- Create a tiered fee structure based on the number of cards in a transaction or on the transaction amount.
- In the example below, if a customer purchases 8 cards, they are charged a per card fee of \$1.50

on each card. If they purchase 15 cards, they are charged a per card fee of \$1.00 on each card. If they purchase 50 or more cards, they are charged a transaction fee(flat fee) of \$25.00.

Transaction Fee

The total dollar value of the cards in the transaction determines the fee.

 In the example below, transactions involving \$1 to \$500 worth of promotional cards get assessed a fee of \$1 per card. Any transaction over \$500 will result in no fees being charged.

Instructions:

In the fields below "Enter Your Fees", enter the fee type (per card or transaction), enter the card type that fee applies to, and enter the amount of the fee. If you are creating a tiered fee structure, you will need to input the Based On column (either Card Count or Transaction) and enter the minimum and maximum ranges for that fee amount. Repeat for all card types.
